The Roger Johnson Patio



This year, in a joint project between undergraduates and alumni, the chapter facilities were able to be improved. Over the course of the last couple of years, the alumni had developed a plan to add a patio onto the backside of the house. Blueville Nursery, under the direction of Keith Westervelt #1014, drew up plans that would allow for the addition of a patio that provided additional leisure, study, and cooking space. This design was presented before the Alumni Board and undergraduate Executive Council in the spring of 2015. The undergraduates, under the direction of Luke Garrison #1735, began to work to raise funds for the project. Naming rights were auctioned off, resulting in the new project becoming the Roger Johnson Patio.

Over the summer months, funds were raised through the donations of alumni and undergraduates alike. Donations of \$500 or more, entitled the donor to a brick upon which he could have inscribed a message of his choosing. Similarly donors of \$1000 dollars were entitled to naming rights of the grill, smoker, and seatbacks, as well as donors of \$2500 were entitled the naming rights of the end capstones and fire pit. With the help of over one hundred alumni and undergraduates, over \$45,000 was raised, and construction of the patio began. Over the course of about a month, Blueville Nursery workers constructed the new patio, and within a couple weeks of the beginning of the fall semester, the patio was complete.



The new patio, which features a pellet smoker, grill, seating, outlets, and firepit, has become a favorite for undergraduates and alumni alike. Undergraduates use the patio as a relaxing end to the long days of classes. Alumni have found use of the grill and smoker on home game days, and all that have used it have enjoyed the beauty and socialization it provides.

Loren Kruse Presented IFBF Distinguished Service To Agriculture Award



Loren Kruse graduated from K-State in 1970 with a bachelor's degree in Agricultural Economics as well as in Technical Journalism. He went on to further his education, receiving a master's degree in Rural Adult Education from Oklahoma State in 1978. Coming out of college, Loren worked for Oklahoma State's Extension Service as a 4-H Editor, and then as an Ag Science Editor, until he transferred to Successful Farming magazine. After working there for 13 years, he became the Editor-in-Chief. He stayed in this position for 23 years, and retired in 2012. He currently owns and operates Kruse Christmas Farm, managing over 2,000 Christmas trees, wreaths, and similar items, as well as Market View Farm, a corn and soybean farm. He lives in Ankeny Iowa with his wife Elizabeth, and children John and Kate.

Loren has been very involved in both his community and national organizations. He has been awarded many honors including AGR National Agricultural Fraternity Brothers of the Century Award, Honorary American FFA Degree, and Distinguished Alumnus from the K-State College of Agriculture. This year, Loren was bestowed yet another award, this one from the Iowa Farm Bureau. This award, the Iowa Farm Bureau Distinguished Service to Agriculture Award, honors "individuals who have played a significant role in the agricultural industry at the local, state and/or national level." This award was only presented to two individuals this year. Both were given a plaque, and their names will be added to a permanent display at the Iowa Farm Bureau Headquarters in Des Moines.

Financial Summary, Alpha Zeta Undergraduate Chapter



Sep. 1, 2014—Aug. 31, 2015 fiscal year

This year was the first year in a few that we did not need to raise the rates for in house living. This was accomplished by more dues paying out-of-house members along with cost cutting within the chapter house. The main cost savings was in food costs; the old budget had \$100,000 budgeted. I trimmed that budget to \$90,000 and stressed the importance of being under budget to our cook. He came very close to keeping the food expenses near \$80,000. Other savings were in utility costs due to the mild spring and fall, along with more house-wide effort to save energy.

Our major philanthropic event for the year, Sell-a-Fella, raised more than \$5,000 for the Cystic Fibrosis Foundation. The auctioneering and clerking labor was donated, along with our stage, so the only associated costs were to rent some heaters and a sound system.

An increased expense was rent to the Alumni Association, which now stands at \$126,080. Also, we changed the compensation packages for our cook and housemother this year. However, with both, we are no longer presenting bonuses which makes true increased costs much less This was done to both update ourselves with the changing costs that were being incurred, as well as to retain them as employees for the foreseeable future.

Financial Summary, Alpha Zeta Alumni Association Sep. 1, 2014–Aug. 31, 2015 fiscal year: Ben Brent, Treasurer

Major Income Items:

Rent: The Alumni Association owns all real estate and rents it to the active chapter. Rent for the 2014-15 fiscal year was \$126,080. Grants from the Chapter Improvement Fund of the AGR Educational Foundation: Many of you have made generous taxdeductible contributions to this fund. That money comes back to the Alumni Association over time. The chapter house after renovation was deemed to be 34.4% educational space. 20% of each year's Foundation contributions are returned to offset fund-raising costs. The remainder was first used to offset 34.4% of construction costs, then 34.4% of annual operating expenses until the fund is liquidated. Last year's grant income was \$53,054.

Direct Donations to the Alumni Association: These are not tax-deductible, and have been mostly in the form of donations of livestock and grain, totaling \$4,878 for the fiscal year.

Major Expense Items:

Maintenance, Repairs and Replacements: \$29,339 for the fiscal year.

Real Estate and Property Taxes: Our real property is currently appraised at \$1,065,280 and is unchanged from last year. 2014-15 taxes totaled \$16,554, but will be \$17,433 for 2015-16, a 5.4% increase.

Property Insurance: \$6,756.

- **Liability Insurance:** The AGR Fraternity carries a national blanket policy based on membership (currently \$173/member). The Alumni Association pays the bill, and is reimbursed for 70% of the cost by the active chapter. Net cost to the Alumni in 2014-15 was \$2,195.
- Other Insurance: The Alumni Association carries Worker's Comp. Insurance on the House Mother and the cook (\$817) and Director's and Officer's Insurance on for the Alumni Board (\$590).
- **Fund Raising:** In 2010, a fund-raising firm (Ivy Partners) was retained to do a feasibility study and manage a campaign to retire our mortgage and fund undergraduate scholarships. That project is completed and our only costs are for managing remaining open pledges and accounting for contributions. During 2014-15 the cost was \$3,600.
- Scholarships: A number of scholarships are available to chapter members through alumni contributions to the AGR Educational Foundation and the KSU Foundation. In addition, the Alpha Zeta Alumni Association funded \$13,000 in scholarships.
- **Mortgage:** Monthly mortgage payments are \$4,121.93. As of the December payment, our mortgage balance is \$137,119 at a rate of 4.325%. A \$40,000 direct principal payment was made in August, 2015. Extra principal payments are planned for 2016 and 2017, with a goal of completion in August of 2017.

To coincide with Pink Rose Formal weekend, the undergraduate and alumni chapter will co-sponsor the second year for the Alpha Gamma Rho Symposium. Undergraduate Chair Nathan Laudan, #1669, and Alumni Chair Garrett Lister, #1616, have been hard at work to continue to improve upon last year's event.

"When Jerrod (Westfahl) approached me with the idea of chairing the event I was hesitant. But when he agreed to let me approach Garrett to be the alumni chair I knew this had potential to be a great event," says Laudan.

The theme for this year's event, as selected by the chapter, will be Biosecurity. Lister says this event will encompass industry, academia and public service points of view encompassing cattle, hogs and poultry production. Invitations to speakers have been sent out and a moderator for a panel has been selected. Speakers include Randy Stoecker, Past President for Murphy-Brown Western Operations, Dr. Dan Thomson, Jones Professor of Production Medicine and Epidemiology at Kansas State University, Jackie McClaskey, Kansas Secretary of Agriculture, Stormy Walker, Senior Technical Consultant for Elanco Animal Health and Dr. Marty Vanier, the director of operations at Kansas State University's National Agricultural Biosecurity Center. Alumni Loren Kruse will be the Master of Ceremonies.. The event will follow last year's format but with some slight alterations.

Speaker time will be shorter with more focus on an in-depth panel discussion at the end says Laudan. The time also has been moved to beginning at 4 p.m. accommodating student schedules to allow maximum participation from across not only the college but also the university as a whole.

"Our hope with moving the time back would be to allow the most students to attend as possible but also allow for alumni to make it back in time for even the panel event," says Lister.

The co-chairmen say arriving late will not be an issues as the event will be held in Town Hall of the Staley School of Leadership Studies, which is meant to be flexible for schedules of attendees. They say that the format of the symposium lends itself to alumni coming in after work or students running in from a class won't miss the finale event, the panel.

"We think we have some great speakers lined up who will do a great job having a lively discussion about the issue of biosecurity and are very excited to talk with students about this topic," says Laudan.

We Did It

\$1.2 Million Dollar Capital Campaign Completed!

The capital campaign that was launched in 2012 has been completed, with over 270 Alumni contributing to this cause! After four years of hard work and diligence by over 100 Alumni, led by chair Dr. Bob Broeckelman, the \$1.2 million goal was surpassed, coming to a grand total of \$1,219,647. This campaign began with three crucial needs: retirement of the debt, building endowed scholarships, and completing priority renovations to strengthen the AGR impact at K-State. Through the efforts of the campaign and other donors, over \$35,000 was awarded during Pink Rose to the undergraduates in the form of scholarships. The next Crescent will have a detailed list of donors, but for now, thank you to all donors who helped strengthen Alpha Zeta and to provide a way forward for our fraternity.
